

Terms and Conditions of Yamaha Music Europe Foundation Competition to win a Scholarship Programme 2024-2025 United Kingdom and Ireland

ARTICLE 1- THE PROMOTER

- 1.1 The promoter is Yamaha Music Europe GmbH, Siemensstraße 22-34, 25462 Rellingen, Germany and Yamaha Music Europe GmbH Branch UK, Sherbourne Drive, Tilbrook, Milton Keynes, MK78BL. The promotion is being conducted by Yamaha Music Europe GmbH and its branch. The Sponsor of the Scholarship Programme is Yamaha Music Europe Foundation e.V. collectively ("Yamaha")
- 1.2 Yamaha reserves the right to cancel this competition at any time by its own sole discretion.
- 1.3 By participating in this Competition, participants agree that they have read, understood, accepted and will comply with these Terms and Conditions.

ARTICLE 2- PARTICIPANTS

- 2.1 Participation in this competition is restricted to students Music students who study at a music college and/or academy/conservatory in United Kingdom and/or Ireland and were born after April 1, 1999, only can take part. ("Participant"). Participants aged under eighteen (18) will receive an email from Yamaha containing a Consent Letter PDF, which must be electronically signed by the Participants' parents and /or legal guardians.
- 2.2 Employees of Yamaha, its affiliates, their families, agents, and other parties directly involved in this competition are not entitled to participate.
- 2.3 There is no entry fee and no purchase necessary to enter this competition.
- 2.4 The application period of the competition for Pre-Elections to determine Finalists, will run from 1st of October 2024 to 30th of November. After this date no further entries to the competition will be permitted.
- 2.5 Each Participant warrants and represents that his/her Content Submission is original. Participants also warrants that their performance is free of third party's rights and must not contain illegal or inappropriate content.
- 2.6 Yamaha reserves the right to verify the Participants' eligibility and /or exclude Participants and its sole discretion at any time and for any reason.

ARTICLE 3- RULES OF PARTICIPATION

3.1 In order to participate in the competition to win a Scholarship amount equivalent to 2000 Euros. The participant must record a video performing of two (2) title/ pieces of Classical music (brass, with or without piano accompany). The format of the recordings should be .MOV or .MP4, the two titles may be recorded separately, but the individual titles may not be cut, re-edited, overdubbed, etc. Sound and image must be recorded at the same time.

The quality of the sound and video does not influence the later selection process, The length of the two recorded pieces should not exceed 20 minutes in total. The two pieces should represent two different styles and this Video should be uploaded to a general public platform (YouTube etc.) to be able to use it as available in link format.

- 3.2 Participants then should fill the online application form and submit their Public Video links mentioned in art. 3.1 within the application form. The online applications should be submitted between 1st of October 2024 to 30th of November. Uploads and application submissions after this date will not be counted. Application forms submitted through the above-mentioned links to Yamaha in connection with this competition collectively defined as "Content Submissions".
- 3.3 Only one entry will be accepted per person. Multiple entries from the same person will be disqualified. No responsibility can be accepted for entries not received by Yamaha for whatever reason. Without following the instruction, the submission will be counted as invalid.

ARTICLE 4- THE WINNER OF THE COMPETITION

4.1 Videos of the participants will be judged based on criteria of Performance by the Jury Members who are experts and professionals at Music Field. The competition will have up to ten (10) finalists who will be chosen by the Jury Members. This chosen finalists will be only pre-selected Finalists and they are not the winners of the scholarship prize. The chosen Finalists will receive an Email from Yamaha about their pre-selection and being Finalists.

The Finalists will be invited to the final, which according to current planning will take place in February/March 2025. The place and the exact date will be announced and contacted by Yamaha where the Finalists should perform face to face in front of the Jury and publicly.

Performance: We understand by performance the fact that the playing demonstrated in the submission displays a high level of timing, expression, execution, sound, and technique.

- 4.2 Jury members are: made up of well-known professors and people from the musical world will nominate the scholarship holder after the audition.
- 4.3 The Winners will be selected by the Jury based on their performance on the Final day mentioned above and contacted through the Yamaha.
- 4.4 The winners have to confirm the scholarship prize. If in any case Winner disqualifies or rejects to receive the scholarship Prize, Yamaha reserves the right to withdraw the scholarship prize from the winner and choose a replacement winner using the same jury.
- 4.5 This competition is in no way sponsored, endorsed, or administered by, or associated with Facebook, Instagram or any other social network. By entering the Competition participants accept that they have no claims against Facebook, Instagram or any other social network in connection with this Competition.

ARTICLE 5- THE PRIZE

- 5.1 The prize for the winners are three (3) scholarships worth amount of 2,000 (two thousand) Euros for each winner for United Kingdom and Ireland ("Scholarship Prize"). Each scholarship prize is worth €2,000. Participants have no right to change, amend or swap this scholarship prize.
- 5.2 The Scholarship prize will be provided to winners by Yamaha.
- 5.3 The Winner will be contacted by Yamaha, with the information provided by participants at the application form such as (Name, email-address, Telephone number, Bank details).
- 5.4 The scholarship Prize can be utilized for any purpose that contributes to the furtherance of the Participant's educational pursuits.
- 5.5 Winner shall not be entitled to assign her/his right out of this competition to any third party or companies within the group and affiliated companies without YAMAHA's written consent.

ARTICLE 6- DATA

Participants consent to personal data being used by Yamaha mentioned in this Terms and Conditions and provided in the Content Submission for the sole purpose of administering and executing of this Scholarship Competition. Moreover, we can process personal data about you where we need to do so in order to defend ourselves against legal claims asserted against us in connection with the application process. We are entitled to do so on the basis of Art. 6 para. 1 (f) GDPR, our legitimate interest being, for example, a duty to provide evidence in proceedings under local anti-discrimination laws. If we agree to grant you a scholarship, we can continue to process any personal data already received from you for the purposes of the scholarship if this is required in order to implement or terminate the scholarship on the basis of Art. 6 para 1 (b) GDPR.

We can disclose your personal data to our affiliates where this is permitted under the purposes and on the legal grounds set forth in this article 6. Moreover, personal data is processed on our behalf on the basis of agreements pursuant to Art. 28 GDPR.

We store your personal data for as long as we need to in order to make a decision about your application. If we do not grant you a scholarship, we may still continue to store data where this is required in order to defend ourselves against potential legal claims. In any case, the application documents will be erased six months after the rejection decision was announced, unless we need to store them for longer due to a legal dispute. Where we store your personal data based on your consent, we will continue to do so until you withdraw your consent. - 7.3 Yamaha is not liable for any costs incurred by the Participant in connection with the competition.
- 7.4 Yamaha reserves the right to refuse unjustified videos, or content submission as well as to withdraw this competition entirely at any time, or to unilaterally modify the Terms and Conditions without incurring any obligations.
- 7.5 Yamaha shall not be liable for any failure to meet these Terms and Conditions where such failure is caused by any supervening circumstances amounting to force majeure.
